

Features of 3rd Dimension Compensation Plan with Rotation:

1st DIMENSION : Everyone Immediately Earns Income From Every Personal Globalpreneurs Customer.

2nd DIMENSION : Beginning With Their FIRST Globalpreneur Everyone Earns Monthly Override Income From The Customers Of Every Globalpreneur in their organization Through Five Levels Of Duplication with no limit to the number of personally sponsored Globalpreneurs one may have on their front line.

This 2nd Dimension plan has:

- a. No qualifiers
- b. No give-ups.
- c. No group-volume.
- d. No Blockage
- e. No balancing legs.
- f. No Caps
- g. No breakaways.

(Note: A small percentage of total potential compensation is allocated to the first two dimensions. The first two dimensions are calculated every week and paid twice weekly. The majority of the compensation is allocated to the 3 Dimension Infinity Cubes.)

3rd DIMENSION: Everyone Earns True 3-D 'Infinity Income' Beginning With Their THIRD Personally Sponsored Globalpreneur.

(The Percentage of Revenue Increases exponentially with every additional Globalpreneur personally sponsored) It is mathematically impossible to receive "True Infinity" Income on "two entire legs" but it is possible to make "3-D Income" work with Absolute

Fairness and Maximum Potential for EVERYONE. (See Rotation explanation below)

a. The Third Dimension creates "Infinity Payfields" over seven cubes.

b. Third Dimension "Infinity Payfields" are not "Limited-Infinity-Bonuses" which can be BLOCKED!

C. Every Person who appears in The FIRST Infinity Payfield has the same relationship to the FIRST Cube Payee as if they were personally sponsored. If 100 Globalpreneurs appear in the FIRST Payfield the effect is the SAME as if The Cube Payee had sponsored ALL 100 people. If 500 people are in the SECOND Payfield the effect is as if 500 more people had been personally sponsored; this same effect takes place across Seven Infinity Payfields.

"CIRCLES-of-Power": Every Personally Sponsored Leg in the Third Dimension are in WEEKLY Counter-Clockwise Motion.

Equity Rotation: The Two Legs that are not in the Third Dimension Income and ALL additional personally sponsored Legs in the Third Dimension are in constant motion.

Compensation is calculated at 12:00 PM PCT Saturday night for the weekly sales volume. After the weekly commissions are calculated each entire leg will move one position counter clockwise. The two positions outside the Third Dimension, positions 1# and 2#, are fixed; the Front-line Globalpreneurs who occupy them are not! So...If you have 4 people on your front-line you will be paid on 2 ENTIRE Third Dimension organizations each week! If you have 12 people that you personally sponsored, you are paid Third Dimension Income on 10 ENTIRE legs each week, etc. This feature removes the "cancer" of manipulation and the capacity to stack the deck. Another Outstanding Feature of The 3rd Dimension Unlimited "True Infinity Payfields" or "Circles-of-Power" creates an amazing retirement insurance potential for

everyone. Every Globalpreneur has the ability to tap into all explosive growth that occurs ANYWHERE beneath them to unlimited depth! If a leg of "1's" runs 50 levels deep and a super business builder appears on the 51st level, all the person on the top has to do to tap into this growth explosion on level 51 is sponsor two or more Globalpreneurs. One week after the 3rd person is enrolled the frontline rotates counter-clockwise right to left; which means the builder on the 51st level will now appear in the FIRST Cube of the person 51st levels above. Now "the builder" and his/her ENTIRE organization will appear in the Person's payfield 51 levels above and they receive 3rd Dimension Pay one week out of every three, assuming they only have 3 personally enrolled. Each new personal recruit by the person 51 levels above increases the amount of time that the explosive volume appears in their 3rd Dimension Pay. Adding one more personal enrollment for a total of 4 personals means two weeks out of 4 they are paid on this volume. If they have 12 personals, they would be paid on that volume 10 out of 12 weeks. (Message: Don't ever dropout, this is the cheapest "insurance-premium" you can find. You are always connected to the results of a growth explosion in your organization . . . no matter how far below you it takes place.)
